


Seat Depth

- Push the lever on the right side of the seat cushion forward to extend the seat forward or backward to a desired position.
- Push the lever to the middle position to lock in place.
- Release lever to lock.




Backrest Recline

- Push the lever located on the right side of the seat to the back position.
- Adjust the back to your desired angle, then push the lever back to the middle position to lock the back into position.
- Push the lever to the back position to release the back rest.



Three Position Tilt Lock

- Locate the handle underneath the right side of the seat.
- Push the lever backwards to allow the chair to tilt.
- Push the lever to the middle position once finished selecting the preferred tilt lock angle.
- The tilt lock is available at three positions.




Back Height & Adjustable Lumbar

- Back height adjustable to three different positions.
- Tension adjustment for lumbar provides stronger or softer support for the lumbar pillow area.



Seat Height Adjustment

- \bullet Lower or raise the seat to your desired height, then release the lever to lock the seat height.




Arm Pad Slide Forward & Backward

Tip: For easier installation, place seat on top of box. Hand thread all screws prior to fully tightening with Allen wrench.




















Preventative maintenance and warning
