



Guideline for wall fixing of 3 Drawer vertical filing cabinet

Step 1

Fully open the top drawer to access the internal drawer latches.


Press the black latch on the lefthand side upward and the black latch on the righthand side downward (as shown) and carefully pull the drawer out to remove.













Step 2

Set the file cabinet to the desired location and mark the center point of the opening on the back of the file cabinet.



Step 3

Remove the file cabinet. Using a Ø6mm drill bit. drill a 2.4 inch (60mm) hole into drywall.







LH SLIDE




Step 4
Press the plastic wall anchor firmly into the hole. Using a hammer, carefully tap the plastic anchor flush with the wall.



Step 5
Set the file cabinet in place and align the hole with the wall anchor.
Secure the file cabinet using the metal washer and screw as shown.
Do not overtighten.



Step 6
Carefully align and re-install the top drawer.


3 Drawer Vertical File
