1. Please take the product out of the carton and place it on the table.



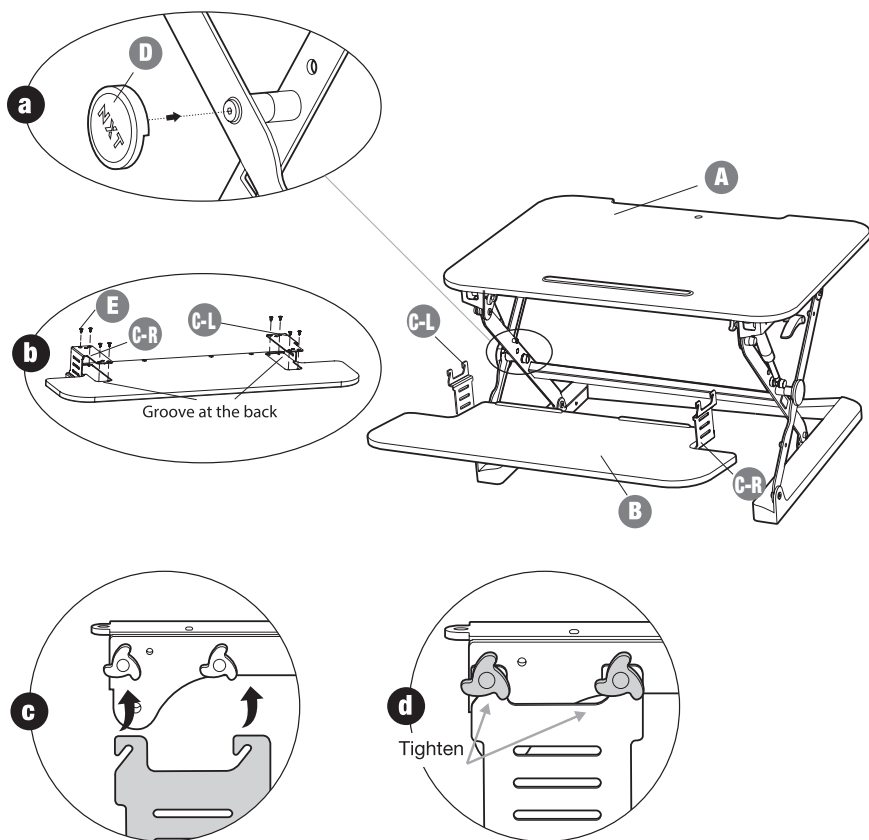
## CAUTION

## ASSEMBLY INSTRUCTIONS - STEP 2

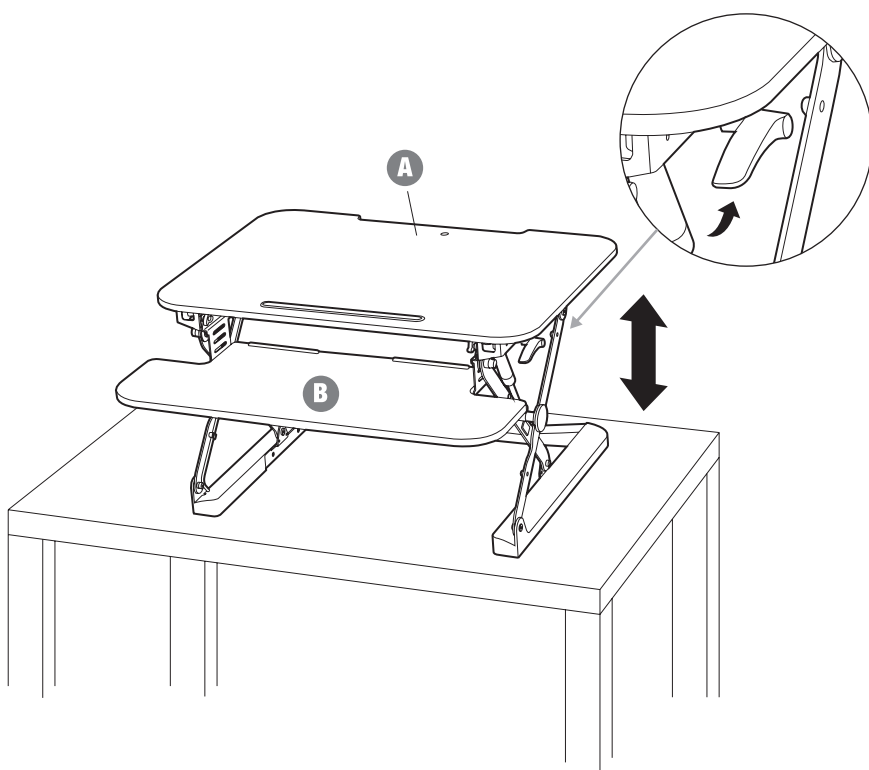
2.

- a: Attach decorative cover to the connecting arm.
- b: Connect and fix the junction plate and keyboard tray using 8 screws.
- c,d: Hang the junction plate on the knob assembled and then tighten the knob.



## ASSEMBLY INSTRUCTIONS - STEP 3

3. Based on the actual usage, press the handle grip on the right side simultaneously, and adjust the workstation to the proper height.

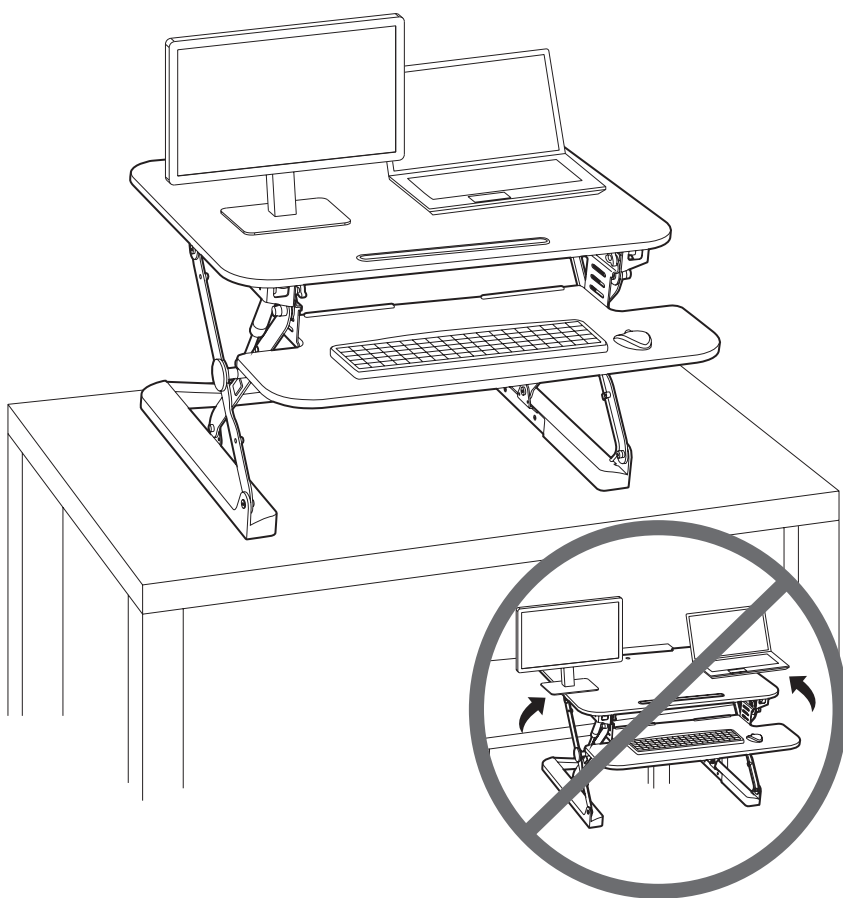


### CAUTION

4. Please put the devices onto the top of the workstation.

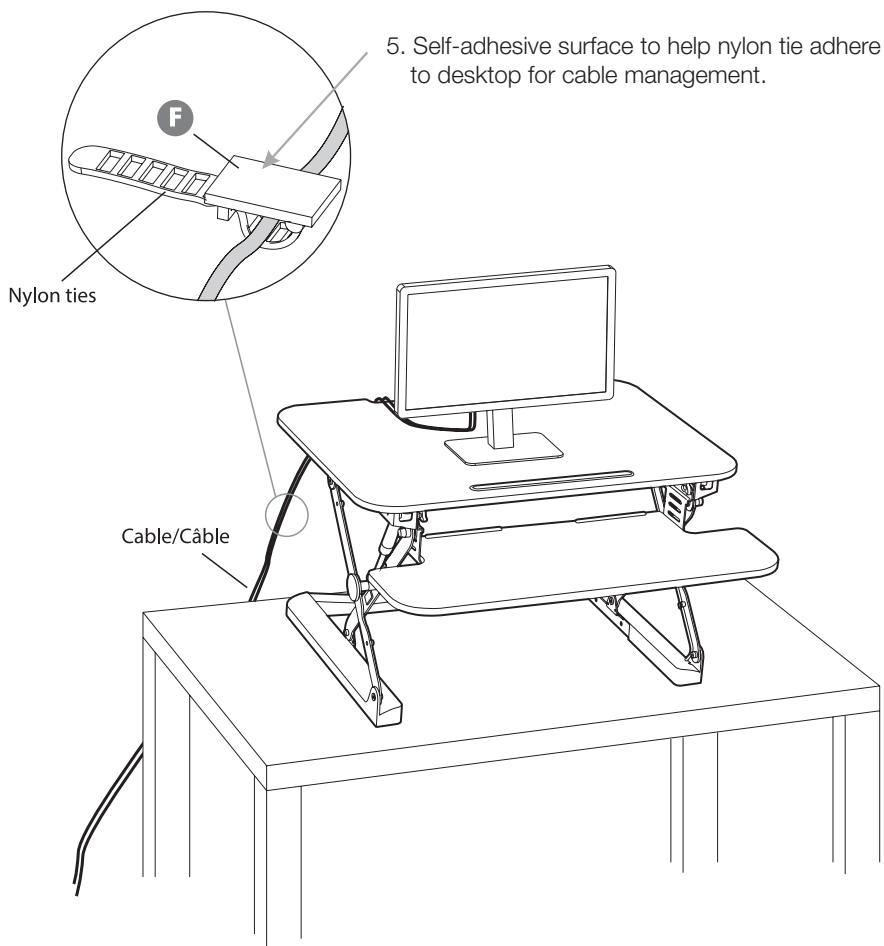


### CAUTION

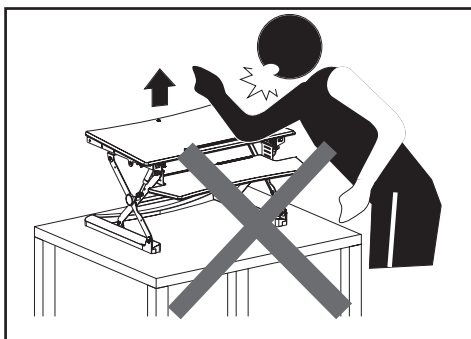

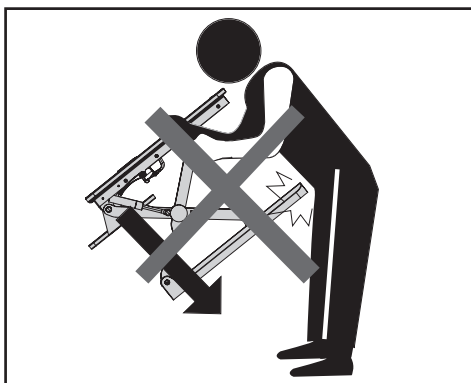
